**Executive Committee Report:** None

<u>Old Business:</u> Linda advised that the FFA Spaghetti Dinner April 1<sup>st</sup> made over \$10,000 for the FFA Program, and the 1<sup>st</sup> Luau on April 22<sup>nd</sup>, made approximately \$1,000 to benefit our local farmers. Info from Lisa to follow next meeting.

Jim Beilgard advised on the Big Day of Service, May 6<sup>th</sup>, he had volunteered at the OV History Museum to assist in cutting down a Eucalyptus tree that needed to be removed. Some of the wood came to the Grange. Jim advised that the Fair Oaks Cemetery had delivered & dumped at the Grange 2 loads of wood chips from their trees that had gone down during the storms.

Luke mentioned from last meeting we had discussed changing our Grange Meeting start time from 7:00 p.m. to 6:30 p.m. Bob advised that we would have to Amend the By-Laws, with a 30-day notice to members and then have a vote at the following meeting. Will discuss at the June meeting, since so many were absent.

Bob reminded everyone to make cookies for the Fair Oaks Cemetery Memorial Weekend Event. Linda will follow up with everyone that signed up to see that cookies and the ice cream cups are delivered on that Friday, May 26<sup>th</sup>. She will be in touch with Barbara Roper and let her know.

Shirley Baker advised that we can get new 8 ft. tables through Lancaster for \$89 delivered, and at Sam's Club it would be \$99 with no delivery, and would have to pick up at Sam's.

Luke asked about the Sponsorship for the Orangevale History Museum. Linda read the information and levels of Sponsorship. After discussion, Jim Beilgard made a motion to be a Silver Sponsor at \$1,000, OVG will be placed on the Wall of Gratitude Perpetual Plaque, Luke VonderOhe seconded. **Motion Carried.**
